Undertaking / Govt. Autonomous Bodies / Semi-Govt. / Statutory Bodies/Local Bodes having credentials of **1 (One) Similar Nature Of Completed Work (longitudinal section of existing drain, topographical details and outfall details)** of the minimum value not less than i) 40% of the quoted amount in a single contract OR ii) two contracts each of at least 30% of the quoted amount OR iii) single running work having completed 80% or more and value of which is not less than as in i) above, during last 5 (five) years from the date of issue of this NIQ.

Tenders will be opened by the **Madhyamgram Municipality, North24pgs, Kolkata-700129** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

3) **Eligibility criteria for the bidders:-**

- Intending tenderers should produce credentials of the minimum value not less than i) 40% of the quoted amount in a single contract OR ii) two contracts each of at least 30% of the quoted amount OR iii) single running work having completed 80% or more and value of which is not less than as in i) above, during last 5 (five) years from the date of issue of this NIQ.
- Bidder should have PAN card, P. Tax, Valid income tax return (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest Valid Trade License, Credentials, Work Order etc.
- Bidders shall not be under Ban/Blacklisting/Debarment for corrupt and fraudulent practices or for lack in performance by any Government/Semi-Government entity.
- Any false declaration and non-compliance of the above would be a ground for immediate termination of the contract and further legal action in accordance with the laws.

- 4) **Earnest Money:-** The tenderer shall have to deposit requisite earnest money along with the tender document in prescribed manner failing which the tender shall be rejected. The balance earnest money if any to fulfill **2(two) percent of the tender value** is to be deposited in the form of DD/Bank Draft/ pay Order issued from Nationalized/scheduled bank in favour, "**Madhyamgram Municipality**" at the time of submission of tender.
- 5) **Security Deposit:** - 10% Security Deposit will be deducted from gross bill value of each every running bill and from final bill without any upper ceiling limit. Deposited EMD will be adjusted as part of security deposit. Refund of security deposit will only be made after 3 months on successful completion of works.
- 6) The Madhyamgram Municipality, North24pgs, Kolkata-700129 reserves the right to cancel the N.I.Q. due to unavoidable circumstances and no claim in this respect will be entertained. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found *incorrect/manufactured/fabricated*, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.
- 7) Before issuance of the Work Order, the tender inviting authority may verify the credential & other documents of the successful bidder if found necessary. After verification, if it is found that such documents submitted by the successful bidders either manufactures or false in that case Work Order will not be issued in favour of the bidder under any circumstances.
- 8) Rates should be quoted clearly both in figures & words for each item and the quoted rates must be inclusive of every demand. No conditional quotation will be accepted.
- 9) **Language of Quotation:-** The quotation shall be submitted in English. All literatures and correspondence in connection with the quotation shall be in English.
- 10) Successful bidder shall have to execute an agreement in the prescribe format which will be available from the office.
- 11) The Tender inviting authority reserves the right to accept or reject any or all the quotations without assigning any reason what so ever.
- 12) **List of common documents shall have to be submitted by each tenderer at the time of submission of last date of receiving quotation.**

 - vi. Work Order for the work in technical credential.

 - ix. Certificate / License of the pilot, who is operating the drone from the competent authority.
- 13) **Scope of Work for proposed construction storm water drainage project from Kuni to Banikantha Khal:-**
 - i. Inception report to be submitted.
 - ii. Feasibility study to be prepared and submitted.
 - iii. Inventory of existing situation to be prepared and submitted.
 - iv. Attribute collection data to be submitted.
 - v. Topographical survey of required area depending upon the nature of topography and availability of land to be conducted using TS and Auto level.
 - vi. Creation of contour map with 0.25m area.
 - vii. Long section with 25m interval and cross section with 2m interval be prepared and submitted as per standard Engineering practice.
 - viii. Outfall study (Banikantha Khal) along with long section, cross section and HFL to be done.
 - ix. Fixation of alignment super imposing on Mouza Map and Municipal Boundary.
