As authorised by the District Magistrate, North 24-Parganas, vide his Memo No. 2311/DMA/N24PGS Dated 07/03/2022 under Section 50B of the West Bengal Municipal Act, 1993, Shri Nilanjan Tarafdar, W.B.C.S. (Exe), DMDC, North 24 Parganas, Executive Magistrate takes the Chair to conduct election of President of this meeting this 16th day of March, 2022 at 12:00 Noon at the Nazrul Shotobarshiki Sadan, Madhyamgram, North 24 Parganas, Kolkata-700129.

Name of Candidate proposed – *ARABINDA MITRA (GANA)* (Ward No. 10)

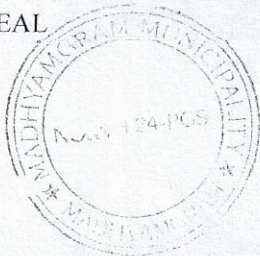
Proposed by – *PRAHLAD KUMAR DATTA* (Ward No. 18)
